Biography

Jeff Cole was recently appointed by United States District Judge James Cain to serve on a panel of neutrals to mediate cases arising from Hurricanes Laura and Delta. Mr. Cole was admitted to the Louisiana Bar in 1980. He is also admitted before the U.S. District Court: Eastern, Middle and Western Districts of Louisiana; and the U.S. Court of Appeals, Fifth Circuit. He was also asked by local Workers' Compensation Judges to form a Workers' Compensation Section of the Southwest Louisiana Bar Association and served as its first President in 2009.

As President of the Southwest Louisiana Bar Association, Mr. Cole accepted on behalf of the organization, the 2006 Pro Bono Publico Award for outstanding pro bono services to the victims of Hurricanes Katrina and Rita.
