### Biography

Before starting her own architecture and construction companies, Ms. Landry, who is also a licensed attorney, was an associate with the Jones Walker Law Firm in New Orleans. Her practice focused on construction and design contracts, real estate and other general business matters.

In 2011 and 2012, Ms. Landry completed several intensive mediation courses offered by Pepperdine Law School's Straus Institute for Dispute Resolution, which *U.S. News & World Report* has ranked as the Number 1 dispute resolution program in the country for 8 consecutive years.
