## **Biography**

He is a Certified Civil Mediator by the Louisiana State Bar Association having completed "Civil Mediation Training" at Lipscomb University's Institute for Conflict Management, which was a 6-day (40-hour) professional course.

Having been admitted to the Louisiana Bar in 1992, Mr. David is also admitted to the U.S. District Court, the Eastern, Middle and Western Districts of Louisiana; the U.S. District Courts for Eastern and Western Districts of Arkansas; and the U.S. Court of Appeals, Fifth, Sixth, and Eleventh Courts. He participated as an advocate in hundreds of mediations over the course of his thirty years of litigation practice.
